

Privacy Notice on Cookies

We use tracking technologies such as cookies, pixels, gifs ("**Cookies**") placed on your pad, mobile phone or computer during your use or visit of our online platforms such as our websites and mobile applications. By means of cookies, the servers of our websites and our applications recognize your devices, such as managing the traffic on the website. Cookies also help us improve our software to provide you with a better experience by analyzing the number and audience of visitors using our website or application.

Your personal data regarding cookies used on <https://www.entekelektrik.com.tr/> ("**Platform**" or "**Website**") may be processed by Entek Elektrik Üretimi Anonim Şirketi ("**the Company**") as the data controller in accordance with the Personal Data Protection Law No. 6698 ("**the Law**") within the purposes specified below.

Purposes for and Legal Grounds of Processing Personal Data

Your collected personal data may be processed for purposes of the conditions and purposes for the processing of personal data specified in Article 5 of the Law, for the below mentioned purposes ("**Purposes**"). Cookies on the Platform are used for different purposes. Depending on the type of cookie used, the data processing purposes and the conditions for data processing under the Law on which we rely when using the relevant cookie may change.

Essential Cookies

Essential cookies are cookies placed on your device and required for the proper functioning of the online services offered during your use of the Platform. For the data processing activities conducted by use of these essential cookies, we rely on the data processing condition envisaged as "***being necessary to process personal data of the parties of the contract, provided that it is directly related to the establishment or performance of the contract***" under Article 5 of the Law.

Performance and Analytics Cookies

Performance cookies allow us to track and analyze the number of people viewing the Website and the Website traffic. By means of these cookies, we may obtain information such as which areas on the Website are most frequently or rarely visited and we may optimize the traffic of the Website.

For the data processing activities conducted during the use of cookies where you explicitly request the relevant information society service and during the use of first-party analytical cookies, which are statistical measurement tools and are used for purposes that do not

significantly affect the privacy of users, such as obtaining general - statistical information, we rely on the data processing condition envisaged as “**processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject**” within the scope of Article 5 of the Law.

In cases where you do not explicitly request the relevant information society service, for the data processing activities conducted during the use of cookies and third-party analytical cookies, we rely on your “**explicit consent**” within the scope of Article 5 of the Law.

Below you can find the different types of cookies that we use on the Website. Both first party cookies (placed by the Platform you visit) and third-party cookies (placed by servers other than the Platform you visit) are used on the Platform.

Recipient Parties and Purposes for Transferring Personal Data

Your personal data may be transferred for the mentioned Purposes, to agencies, consultants and other technical service providers whom we provide services, to legally authorized public authorities and legally authorized private institutions within the scope of that is expressly provided in the laws and fulfillment of our legal obligations, in accordance with the personal data transfer rules specified in Article 8 of the Law.

Certain cookies used on the platform are provided by third-party service providers other than the Company. In the presence of your explicit consent, your device identification data and

cookie records may be transferred in accordance with the rules regarding the transfer of the personal data specified in Article 9 of the Law, for the purpose of separating bots from users visiting the Website and generating statistical data on the use of the Website to Google LLC residing abroad, within the scope of the data processing conditions specified in Article 5 of the Law.

Method of the Collection of Personal Data

Your personal data is collected via cookies placed in the Website in electronic environment within the scope of fulfilling the above-mentioned Purposes.

Data Subject's Rights Specified under Article 11 of the Law

We hereby declare that as personal data subjects, you are entitled to the following rights, set forth under Article 11 of the Law:

- To learn whether your personal data are being processed,
- To request information if your personal data have been processed,
- To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- To learn which third parties domestic or abroad your personal data has been transferred to,
- To request rectification in case your personal data has been processed incompletely or inaccurately and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To demand the erasure or destruction of your personal data in the event that the reasons for the processing no longer exist even though it was processed in accordance with the Law and other relevant provisions and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To object to negative consequences to you that are concluded, as a result of analysis of the processed personal data through solely automatic systems,
- To demand compensation for the damages that you have suffered as a result of an unlawful processing of your personal data.

Depending on the nature of your request, your application will be concluded as soon as possible, within 30 days at the latest and in principle, free of charge. However, if the process requires additional costs, a fee may be demanded according to the tariff determined by the Personal Data Protection Board.
